Your Scheme

CROWN GUARANTEE

The Aircrew Scheme is a defined benefit scheme. The benefits payable by your Scheme are guaranteed by the Crown.

INVESTMENT PERFORMANCE

The asset class returns (before tax and expenses) and the comparative performance of the benchmark indices are shown in the table below.

EMPLOYER CONTRIBUTION RATE

Each year the Board's Actuary carries out a review of the Scheme to determine an employer contribution rate sufficient to meet the accrued and future liabilities of the Scheme.

In the actuarial review, completed as at 31 March 2020, the Actuary recommended the employer contribution rate be maintained at 390% of contributors' contributions from 1 April 2021. The recommendation was accepted and endorsed by the Board.

* The funding level has been calculated on the funding basis using a discount rate of 3.1% pa net of tax and investment related expenses (2020: 2.4% pa). Calculating the funding level on a minimum risk basis (and a discount rate of 0.49% pa (2020: 0.39% pa) would give a funding level of 96.1% at 31 March 2021 (31 March 2020: 86.9%).

The other financially significant assumptions for the Scheme are:

- The rate of future salary increases assumed over the next 10 years for pilots. This assumption has changed. The new assumption is that there will be 1% pa promotion for pilots plus 1.9% pa salary escalation for the first ten years and 2.0% pa thereafter for both pilots and cabin crew. The previous assumption was that there would be no future salary increases or promotion.
- The ages at which contributors are assumed to retire, although this has less impact on the contribution rate as a multiple of contributors' contributions.

The value of past service liabilities above assumes members continue in the Scheme until their expected retirement date.



COVID-19 IMPACT

Around the world the Covid-19 outbreak has led to significant economic slowdown and volatility. These disruptions are likely to continue into the foreseeable future and provide uncertainty for the value of the investment assets and the income earned from them. For the year ended 31 March 2021 the Scheme has recorded a gain from unit funds of \$8.32 million. This compares to a loss of \$1.52 million in the previous year. The Board continues to monitor the impact of the movements in the market on an ongoing basis.

During the year the membership numbers fell to 28, or by 48%, as members retired or transferred out of the Scheme. In some cases this was prompted by industry changes as a result of Covid-19.

SUBSEQUENT EVENTS

There were no material events subsequent to balance date requiring amendments to these financial statements.

The Board certifies that, to the best of its knowledge, all benefits required to be paid from the Scheme were paid in accordance with the terms of the Scheme trust deed.

The Board based on the advice of the Actuary certifies that, as at 31 March 2021, the market value of the net assets of the Scheme was less than the total value of the vested benefits of the Scheme under the funding basis.

FEES

Scheme administration fees are calculated on fee per member and fee per transaction bases and are charged to the Scheme as a whole. Effective 1 October 2020, the administration fees increased in line with inflation. The Board certifies it is satisfied the increase in the administration fees for the Scheme is not unreasonable. The Board is satisfied the total management fees charged to the Scheme are not unreasonable.

TRUST DEED AMENDMENT

The Scheme trust deed was last amended on 6 May 2021 (after year

end). The amendments are effective from 30 January 2021 and were made following the repeal of the Trustee Act 1956 to address the changes brought about under the Trusts Act 2019. A copy of the trust deed is available on request.

INDEPENDENT AUDITOR'S REPORT

We did not evaluate the security and controls over the electronic publication of the summary financial statements.


